Getting started with the Declarations API

What is a declaration?

A credit insurance declaration of turnover is a regular report that customers submit to Atradius detailing their insured sales/revenue for a specific period. This helps to calculate insurance premiums, maintain accurate coverage levels, track insured customer transactions, and ensure compliance with policy terms.

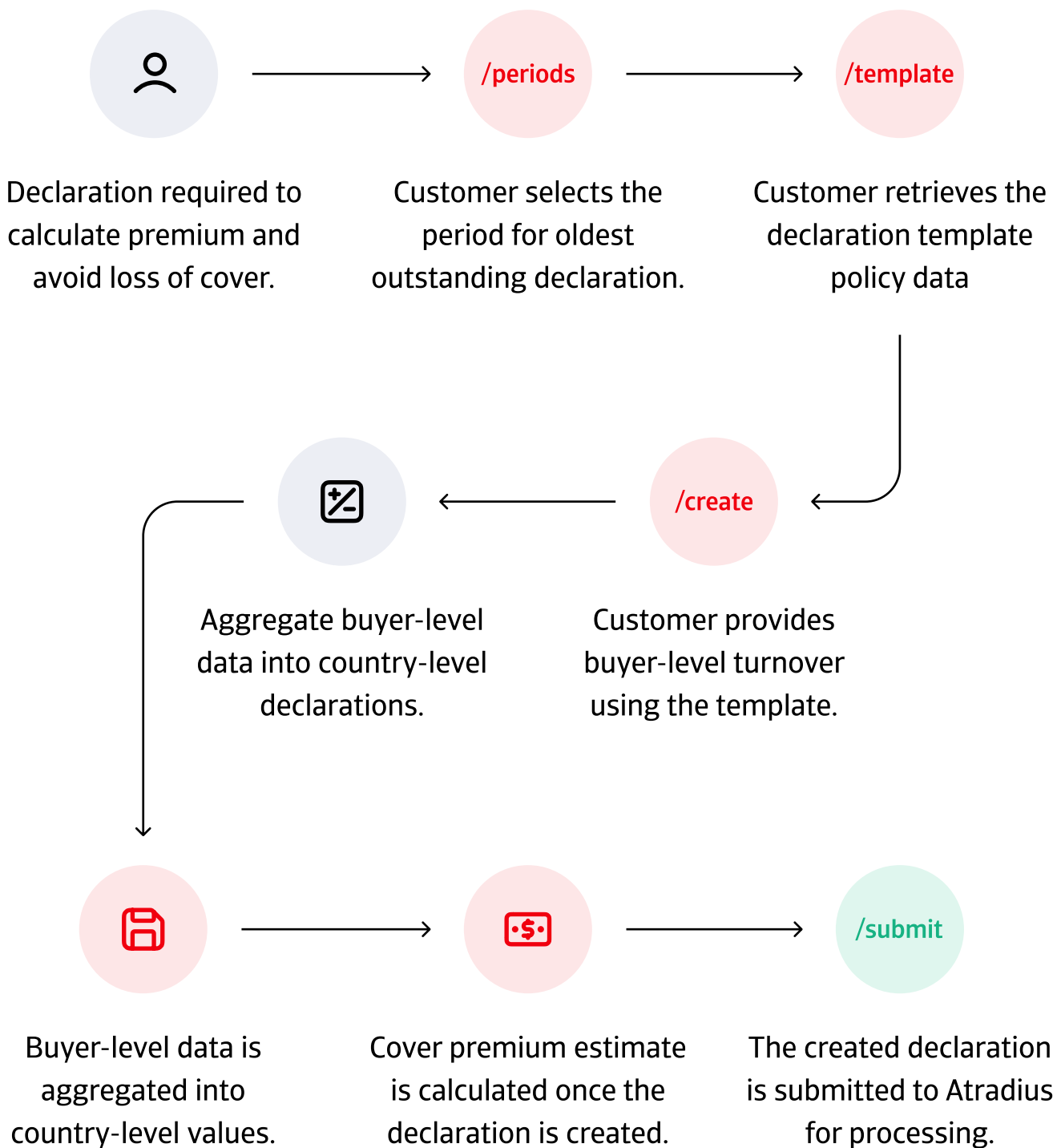
This API facilitates monthly declarations on a buyer level. The operational effort to aggregate the values will be taken care of by Atradius and will take policy conditions into account.

Common terminology

Buyer-level	Declaring for individual buyers as opposed to declaring at a country level.
Declaration periods	The policy schedule that specifies the time period when customers must submit their declarations.
Template	An API endpoint that returns the policy information (e.g. payment terms) needed to create a declaration.
Payment terms	The amount of time given to buyers for payments, as defined in the policy

API endpoints

GET Get Declaration Periods

Retrieve the period for oldest outstanding declaration, or a previously submitted period if creating a supplementary declaration.

GET Get Declaration Template

An API endpoint that returns the policy information (e.g. payment terms) needed to create a declaration.

POST Create a Declaration

This endpoint allows the user create a new declaration against a policy for a specific period.

PATCH Submit a Declaration

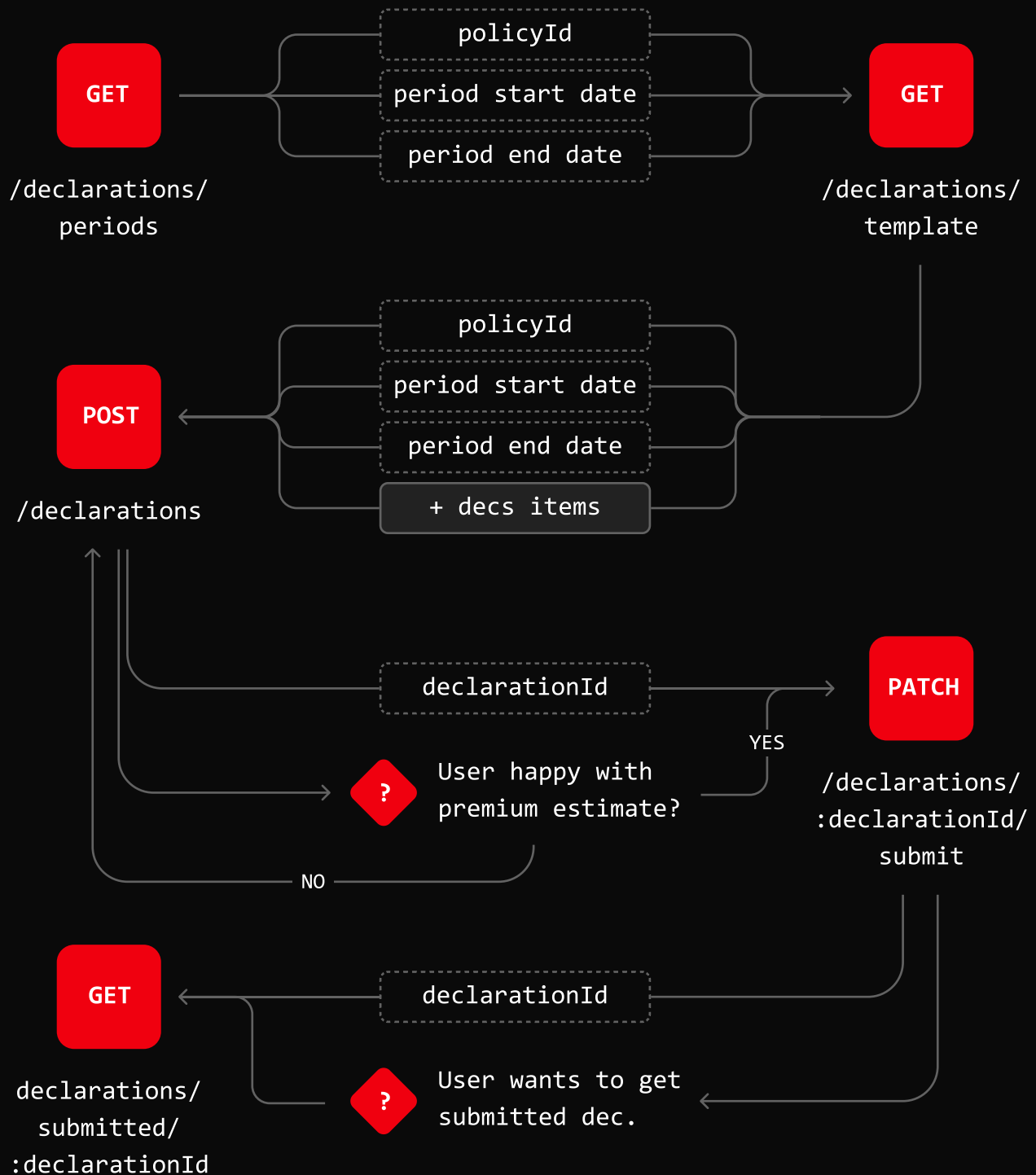
This resource allows users to submit a previously created declaration against a policy.

GET Get Submitted Declaration

This resource allows users to retrieve a previously submitted declaration against a policy.
